1. Funding

- Informal structure of the Coalition should continue ?
- This year, try-out
- Members contribution: choice between 500 – 1000 – 3000
- ASC, BOTH ENDS, ELD, Farm Africa, FAC/ IDS/FUT AGRIC, HPG/ODI, Kimmage, MRG, PENHA, Terra Nova: continue membership but could not contribute financially this year
- Solidarity: bigger ones compensate for smaller

1. Funding

- Minimal need: 25 000 euros/25 EU members = 1000 euro/member
- However too much for some to bare.
 - Suggestion: continue with the proposed scheme: 500
 - 1000 – 3000
- Funding:
 - EU: NSA/LA call soon, follow-up on 2012 pledge to write a proposal.
 - Working group? To take into the pledges for 2013?
 - Other donors? Inclusion of other stakeholders (private sector?)

2. CELEP/CELAP

- Exchanges through email
- Conclusion CELEP becoming CELAP too complicated
- Suggestion:
 - Harmonisation with W-Af.
 - Contacts with RBM and APSS: inform on CELEP
 - Through Plateforme Francophone de Communication des Pasteurs de l'Afrique (google group –IUCN)

3. Focal Point Election

- Rotates among European members of CELEP.
- Elected in CELEP AM (EU members & EA partners present)
- Functions as the “*official*” CELEP spokesman/voice in EU.
- Monitors implementation of actions pledged during CELEP.
- Identifies (unforeseen) lobby opportunities and mobilizes responses from CELEP EU members and EA partners.
- Handles organizational issues with support of CELEP members/partners
- When necessary: requests advise & inputs from Core Group
- VSFB 2013, previously Cordaid. VSFB continues in 2014

4. Core Group

- Members elected every year during CELEP annual meeting (50% new each year)
- Voluntary basis (no covering of costs)
- Advises and guides the CELEP Focal Point
- Decides about sensitive issues in between the plenary meetings of CELEP
- 2014: VSFB, Cordaid, Concern and COPACSO
