I. Expected Results/Outputs – Priorities for 2019 - 2023

1. Strengthened joint mechanisms for cross-border peace building, community resilience, and conflict prevention, management and resolution.

2. Strengthened evidence-based regional collaboration, cross-border cooperation and harmonization of policies and programmes for peace and security.

3. Enhanced investments and access to social services in the Karamoja cluster with a focus on children, youth and women.

4. Increased collaboration in sustainable environment and utilisation of shared natural resources.

5. Improved community security & resilience to natural/man-made shocks, enhanced use of shared natural resources and Diversified livelihoods.

II. Interventions/ Activities

(a) Funded Priorities for 2019

Output 1. Strengthened joint mechanisms for cross-border peace building, community resilience, and conflict prevention, management and resolution.

(i) Stakeholders' mobilisation, sensitization and awareness creation on MoU.

(ii) Harmonize community peace agreements with new policies and commitment.

(iii) Capacity development for Peace Committees..

(iv) Support cross-border dialogues and traditional conflict resolution mechanisms.

(v) Support commemoration of major Peace events.

(vi) Support joint security cooperation and coordination.

Output 2. Strengthened evidence-based regional collaboration, cross-border cooperation and harmonization of policies and programmes for peace and security.

2.2 Research, Knowledge and Technology

- (i) Joint vulnerability/resilience assessment (causes, drivers, dynamics, and impacts of conflict, and changing livelihood systems)
 - **(Already funded on Uganda side, process ongoing with focus on Karamoja Cluster and Rwenzori. Kenya has prioritised this 2019).**
- (ii) Joint GIS mapping to identify spatial distribution of resource opportunities.
- (iii) Documentation of best practices.

Output 3: Enhanced investments and access to social services in the Karamoja cluster with a focus on children, youth and women.

- (i) Support implementation of peace dividend projects (implement two projects in W. Pokot County (Primary School classrooms at Nasal (Naita) and Equipping a secondary School for PWD)
- (ii) Provide 5 motor cycle ambulances for five districts of Karamoja to support health care services for mothers.

Output 5. Improved community security and resilience to natural and man-made shocks, enhanced use of shared natural resources and Diversified livelihoods.

- (i) Support implementation of peace dividend projects (implement 1 water supply project in Urum, Turkana County)
- (ii) Open up 1 priority security road: TBD from (Kamion-oropoi), Komwate-Nawounitos, Loredo-turuturu, Kanadae-loitanit), and others.
- (iii) Drill 10 new boreholes in grazing corridors/areas
- (iv) Map dilapidated boreholes to inform prioritisation of boreholes to repair.
- (v) Solar panels for health centre – Kamion, Amudat, and other priority health centre to harness renewable energies to improve health services

(b) Mid Term Priorities for 2020-23

Kenya - Mid-term Indicative Interventions, 2020-2023

- 1) Support cross-border programme **coordination structures at national, county and local levels**
- 2) Develop & promote **knowledge-sharing platforms and systems**
- 3) Develop **cross-border programme monitoring and evaluation framework**
- 4) Support capacity enhancement and facilitation of **joint monitoring and evaluation missions.**
- 5) Support **mapping and analysis of sustainable cross-border projects**
- 6) **Mainstreaming cross-border programme in national and county planning and budgeting**
- 7) **Support to Peace and ADR Structures: Strengthening Peace Committees, Integrating peace into the school curriculum, Policies, strategies for enhancing governance**
- 8) **Integration of gender in cross-border peacebuilding and socio-economic development**
- 9) **Investment in drought resilience and climate change adaptation:** Climate smart agriculture, Ecosystem based adaptation to climate change and eco-DRR, Climate Change information management , Enhancing Livelihood options (value chain), Promotion of fodder/pasture production and conservation, Livestock marketing infrastructure
- 10) **Rangeland restoration**
- 11) **Water Resources Management Project:** Construction of Dams and other RWH structures, Revegetation/Vegetation cover (afforestation etc), Water and sanitation projects, Assessment and Mapping of Water resources, Water management planning
- 12) **Improved livestock and human disease surveillance, vaccination and treatment:** Livestock health (vaccination, treatment and disease surveillance), Provision of community health services including mobile and referral system, Construction of health facilities at Akiriamet, Apuke, Losamo and Namura and recruit staff, Integrated monthly health and nutritional outreaches
- 13) **Climate – proof infrastructure:** Konyao – Alale road upgraded to bitumen standards, Konyao – Kiwawa – Amudat, Construction and upgrading of priority roads
- 14) **Support education programmes:** construction, expansion and equipping a Vocational Training Centers at Alale, Support Nomadic schools

Uganda - Mid-term Indicative Interventions, 2020-2023

Joint mechanisms for cross-border peace building, community resilience, and conflict prevention, management and resolution

- 1) Strengthen internal and cross-border justice, law and order systems (Cattle theft control measures, traditional justice system)
- 2) Early warning and early response mechanisms
- 3) Systems for control of proliferation of small arms and light weapons (RECSA)
- 4) Support civil-military cooperation centres
- 5) Strengthening role of traditional institutions in cross border cultural engagement
- 6) Support community mobilization and awareness raising (engage elders, local leaders, local traders, religious leaders)

Collaboration, cooperation, harmonization of policies and programmes, and Research, Knowledge (evidence)

- 1) Coordination meetings: technical & policy reviews, implementation/progress review and Regional and Inter Agency Meetings
- 2) Joint Communication and advocacy (communication tools, visibility)
- 3) Periodic Joint vulnerability/resilience assessment
- 4) Joint GIS mapping to identify spatial distribution of resource/opportunities
- 5) Documentation of best practices

Enhanced investments and access to social services with focus on children, youth and women.

- 1) Improve accessibility and quality of education: enrolment, retention, numeracy and literacy
- 2) Increasing access for health facilities in new districts (infrastructure, equipment, drugs & community health workers, staffing and training) esp. border districts
- 3) Strengthen Social protection system (targeted safety nets)
- 4) Women and Youth economic empowerment and participation
- 5) Prevention and response of GBV, FGM, Early Marriages, Teenage Pregnancies
- 6) Cross-border engagement on alternative rights of passage
- 7) Tackling child labor in agriculture
- 8) Male engagement (building positive masculinity)

Uganda - Mid-term Indicative Interventions, 2020-2023

Improved community security & resilience to natural and man-made shocks; enhanced use of shared natural resources and diversified livelihoods.

- 1) Improve **crop and livestock production and productivity** (breeding, drought resistant/adaptive varieties, supporting regional research institute, pests and disease management, animal tractions (equipment/tractorisation))
- 2) **Diversification of livelihoods, enterprise and market development** (value chains development – agro-processing and marketing), strengthen mining/development minerals, access to finance, access to affordable energy, tourism
- 3) **Roads and bridges** (construction, rehabilitation, and maintenance of gravel roads); Moroto-Lodwar Connection, Amudat-Kapenguria, Kaabong to Kaakuma, Kotido-moruitit (**prioritise trade and security roads**) (TBD: (Kamion -oropoi), Komwate-nawounitos, Loredot-turuturu, Kanadae-loitanit)
- 4) **Water for production** (water harvesting using various technologies; dams/strategic water reservoirs targeting the cross-border grazing corridors – Jie-Turkana, Dodoth-Turkana, Pokot-Matheniko, Pokot-Pian/Kadam grazing areas); exploring alternative technologies (wind, solar); **safe water** – high yielding boreholes; rehabilitation of dilapidated boreholes, strengthen operation and management of water facilities (mindsets, management – link this to the committees, monitoring – sustainability)
- 5) **Harness renewable energies** (wind, solar, biogas, energy saving stoves) for use at household and commercial levels in the region; promoting rural electrification with the region.
- 6) **Telecommunication and ICT:** connect backbone infrastructure to all the districts in Karamoja (fibre optic cabling)
- 7) Regional Markets
- 8) Strengthen/ease customs and immigration process, (establishing infrastructure)
- 9) Harmonization of regulations (land for investment, access to affordable financing, harmonization to facilitate free movement,
- 10) Support cooperatives and trader associations
